INFORMATION FOR SUTLERS, VENDORS AND DRUMMERS

NEW MEXICO SALES TAX:

- SASS will be supplying your company's contact information to the State of New Mexico Special Events Tax Examiner's office prior to Buffalo Stampede. Included in your Vendor Packet are the required forms you must complete and return to their office at the close of the event. It is your obligation to complete and return the appropriate forms. If you have additional questions regarding the Special Events tax, contact the New Mexico Special Events Tax Examiner at 505-841-6266.

TEMPORARY BUSINESS LICENSE:

- Every Vendor must obtain a temporary business license through Torrance County. You may request an application by calling: (505) 246-4735. There is an \$8.75 fee for this application.

BOOTH SPACE:

- Self-Contained Space only is available, unless prior arrangements have been made with event management.
- Some vendor buildings may be available for exhibiting in, depending on availability. *Returning your exhibitor application and fee early will increase the chances of being placed in a vendor building to exhibit.*
- Every Vendor must pre register by April 15, 2013.
- Exhibitor fee for Buffalo Stampede is \$100.

ALL BOOTHS:

- Set-up can begin Tuesday, May 7th. Vendors must remain open through Saturday, May 11th until 5pm.
- Vendors are encouraged to open earlier and/or close later to serve the shooters and their guests.
- **Trash** pickup is the responsibility of vendor in the vicinity of their exhibition space out to five feet. Vendors who leave behind excessive trash after the event will not be invited back.

VENDOR PARKING:

- Vendor fees includes space for ample parking for exhibitor and booth staff.
- After unloading and exhibit set up, all vehicles must be moved to the appropriate parking areas, as directed by event management on site.

CAMPING:

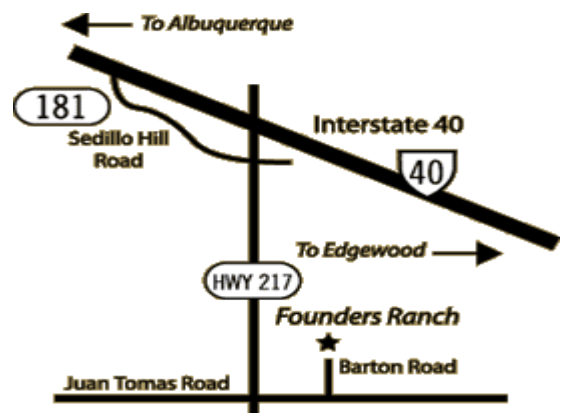
- Camping at Founders Ranch *is included* in your vendor fee.
- All camping spaces must be reserved in advance and should be indicated during initial application.
- Founders Ranch is a "dry" campground with no hook-ups or electrical available.

ELECTRICAL:

- Electrical power (115v) is available on a limited basis, first come-first served, from Wednesday thru Sunday.
- No power is available for campers or trailers.
- The cost for electricity is \$50.00 and includes one 20 amp outlet box.

MISCELLANEOUS:

- You must be a SASS member to be a vendor at Founders Ranch.
- All Founders Ranch rules, Pet and Camping policies must be adhered to at all times.
- Pets must be contained in your booth. If they present a problem they must be removed.
